



This Post – Graduate Affiliation (here in after referred to as “the Agreement”) between Wilmington College (Wilmington) and Cincinnati State Technical and Community College outlines a mutually beneficial agreement in which Wilmington College will offer preferred status to graduates of Cincinnati State Technical and Community College who enroll in the Master of Science in Occupational Therapy (MSOT) program at Wilmington College.

Pursuant to this agreement, Wilmington College will provide preferred admission status and enrollment benefits to graduates of Cincinnati State Technical and Community College who seek to enroll in Wilmington College’s Master of Science in Occupational Therapy program as outlined below:

Master of Science in Occupational Therapy – GUARANTEED ADMISSION

Wilmington College (WC) will provide Guaranteed Early Admission for up to (3) qualified candidates from Cincinnati State Technical and Community College (CSTCC) contingent on the following conditions:

- 1.) CSTCC students must notify Wilmington College of their intent to enroll in the Master of Science in Occupational Therapy program and pay a non-refundable \$500 deposit (applied towards their first semester of MSOT tuition) by September 1st for the spring (January) term of the current academic year (according to Wilmington College’s published graduate calendar).
- 2.) CSTCC students must complete an application through the Occupational Therapy Centralized Application Service (OTCAS) by September 1st for the spring (January) term of the current academic year.
- 3.) CSTCC students must successfully complete all published MSOT prerequisite admission criteria by the start of WC MSOT coursework.
- 4.) Students must successfully complete all CSTCC occupational therapy assistant didactic coursework and fieldwork by the start of WC MSOT coursework.
- 5.) Students must successfully pass the NBCOT occupational therapy assistant exam by the start of WC MSOT coursework.

This agreement will be rescinded for students who fail to meet these conditions, for any reason. Additional Cincinnati State Technical and Community College applicants will be considered on a space-available basis.

In exchange for Wilmington College Providing guaranteed admission to graduates of Cincinnati State Technical and Community College, Cincinnati State Technical and Community College will provide the following:

- Promote this collaboration and Wilmington College's Master of Science Occupational Therapy program directly to its student through email, verbal announcements, and other appropriate graduate school-related communications.
- List the enrollment benefits associated with this MOU on an appropriate webpage that would be easily accessible by students.
- Provide exhibit opportunities for Wilmington College at relevant career and graduate school recruiting events.

This Agreement will automatically renew annually on _____ unless cancellation or updates are received in writing. Either party may terminate this agreement by providing 30-day notice in writing of its intent to cancel.

Nothing in this Agreement shall be deemed or construed by Wilmington College or Cincinnati State Technical and Community College or by any third person to create the relationship of principle and agree or of partnership or of joint venture.
