She enjoys traveling around the world on mission trips, being a motivational speaker, providing budget and financial counseling, and working with the prison ministry of restoration and reconciliation for incarcerated parents and their children. Elizabeth's handwritten thank-you notes to donors are just one example of her time commitment to WC. Elizabeth is also a strong supporter of the Spanish program for which she often issues matching gift challenges to donors of the program. She also supports student initiatives and is committed to the continued funding of the Copithorne Family Endowed Scholarship.
