1. Purpose

Wilmington College will require physician services for its Student Health Center (and related collaboration with the Student Counseling Center) beginning in the Fall 2026 semester, with services to start on or about August 10, 2026.

Through the RFP process, the College also further welcomes conversation about potential physician services for employees, non-physician practitioner health services, and additional partnership opportunities which may be developed over time, consistent with the College's Mission, Vision, Quaker Values, and academic character, as discussed below.

2. Fall 2025 Institutional Profile

Located in the City of Wilmington, Clinton County, OH, the College enrolls approximately 1,100 students across all programs and employs approximately 175 faculty and staff.

A member of the Ohio Athletic Conference, approximately 50% of the College's undergraduate students participate in varsity athletics at some point during their time at the College.

The College, as lessor, leases commercial, on-campus space to Beacon Orthopedics, Drayer Physical Therapy, and Mersch Chiropractic Care, which provide patient services in that leased space.

Mission Statement

4. The Opportunity

At the conclusion of the Spring 2026 semester (May 2026), the community physician currently providing medical services at the College's Student Health Center will retire.

The College seeks a new partner to provide physician services for its Student Health Center, with services beginning on or about August 10, 2026. Scope of services will include student primary care typical of a college or university student health center, including collaboration with and acceptance of referrals from the College's Student Counseling Center.

Through the RFP process, the College further welcomes ideation and conversation about physician services for employees, use of non-physician practitioners in care delivery, and additional partnership opportunities which may be developed over time, consistent with the College's Mission, Vision, Quaker Values, and academic character.

These additional initiatives under consideration may include, but are not limited to:

- On-site physician services for College employees This is a high priority topic for conversation.
- Development of health-care focused academic programs offered through partnership with the College (e.g. respiratory therapy, nursing...).
- Support of the College's intercollegiate athletics programs (e.g. student-athlete physicals, athletic training...).

- External-facing, civic-minded, partnerships which advance the mutual interests of the College and the partner and which support economic, service, educational or other worthwhile goals within region.
- Other opportunities which the College and partner may, from time to time, mutually wish to pursue, including certain College sponsorships.

5. Specific Requirements

While recognizing that potential partners must adhere to their own legal and regulatory requirements, industry and professional standards, and internal operational practices, notwithstanding, the College generally requires that the partner:

- Will engage in good faith with the College to incorporate current College employees
 providing health care services (such as nurses) into the partner's plan for provision
 of services, in a manner consistent with College employees' current responsibilities
 and economic arrangements.
- Will engage in good faith with the College to continue specific activities and educational services presently provided by College employees through the Student Health Center and Student Counseling Center, which may include, but are not limited to:
 - o First-aid, CPR, and AED trainings for students and employees; and
 - Instruction for employees on how to recognize and refer students in behavioral health crisis.
- Will engage with the College to properly orient individual practitioners and other staff to the College's Mission, Vision, and Quaker Values and set on-site performance expectations consistent with the College's academic character and Quaker heritage.
